**EVENT LICENSE, RELEASE, HOLD HARMLESS,
WAIVER AND INDEMNITY**

The undersigned, being an owner of a horse, or participant in an equine activity at Lord Hill Stables, LLC or spouse, parent or step-parent or individual responsible for a minor or disabled person, voluntarily enters into this agreement which is based upon the following recitals, terms, conditions and provisions:

RECITALS

A. Risks of Injury and Death

I do understand that equine activities are considered dangerous and can result in serious injury and even death to persons engaging in these activities. Horses are subject to flight or fight instincts when placed in a situation in which the equine feels threatened. No amount of training can eliminate this instinct possessed by the equine and thus the equine is to be considered a possible danger to myself and to those persons engaging in all activities involving the equine.

B. Hazards of Horses

I acknowledge that horseback riding and equine-related activities have inherent risks, hazards, and dangers for anyone which cannot be eliminated. I acknowledge that being involved with horses can be a hazardous and unpredictable undertaking. Such hazards including injury or death, falling, being kicked and/or bitten.

C. Releasors

The undersigned is acting individually and on behalf of others, including spouse, children, guests, wards, all of whom hereafter are referred to as **RELEASORS**.

D. Releasees

For the purpose of this agreement, **RELEASEES** are the owners of the real property occupied by Lord Hill Stables, LLC and are the Lord Hill Stables, LLC its owners, employees, agents, and volunteers.

**IN CONSIDERATION OF THE FOREGOING, THE FOLLOWING RELEASORS
AGREE AS FOLLOWS:**

1. Waiver

The RELEASORS specifically waive the right to present any claim against Lord Hill Stables, LLC and the other RELEASEES as defined above and as such covenant not to bring claims or suits against the RELEASEES for any property damage, personal injury, bodily injury, paralysis or death sustained by any RELEASOR while at Lord Hill Stables, LLC .

2. Release

The RELEASORS, individually and on behalf of other RELEASORS, assume all risk, the hazards and dangers involved, including risk of injury, paralysis or death, and assumes full responsibility for their conduct and for any property damage, injuries, or death sustained by said RELEASORS resulting from and arising out of equine activities at Lord Hill Stables, LLC, however caused, including by the negligence of the RELEASEES.

3. Abide by Rules

The RELEASORS agree to abide by all Stable Rules, which are posted on the Notice Board in the stables and which may be amended from time to time.

4. Hold Harmless and Indemnity

The undersigned RELEASOR, individually and on behalf of those individuals for whom he/she is executing this agreement, hereby hold harmless and indemnify the RELEASEES from and against all claims, actions, demands, expenses, liabilities (*including attorneys fees*) and negligence of said RELEASORS and/or arising out of the RELEASORS involvement in equestrian activities, where such claims are presented by third parties or by representatives of the RELEASORS against the RELEASEES whether such claims arise out of the RELEASOR'S use of the property, involvement with animals, or arising out of the other activities of the RELEASEES and the management of Lord Hill Stables, LLC, or condition of the facilities.

5. Subrogation and Disclaimer

The RELEASORS, individually and on behalf of those individuals for whom they sign this agreement, hereby waive any subrogation claim for property damage, veterinary or human disability, medical insurance or mortality or life insurance; and further agree not to disclaim any interest in the estate of any injured or deceased RELEASOR authorized by RCW 11.86.
